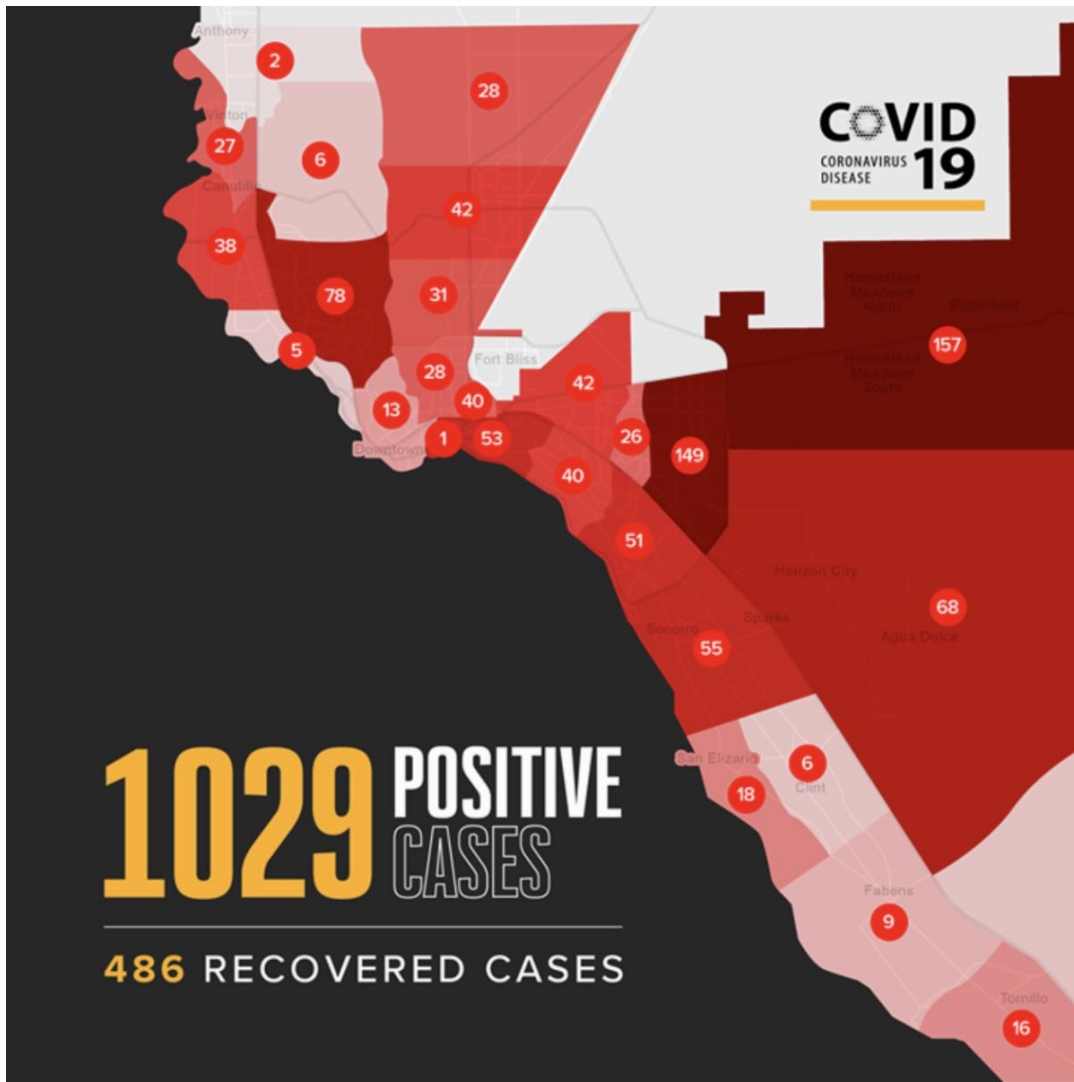

### Positive Cases Reach Over One Thousand

The City of El Paso Public Health Department is reporting 31 new COVID-19 cases bringing the county's cumulative number to 1,029, the number of deaths remains at 22.

To-date 486 people have recovered from COVID-19; consequently, there are 521 active cases within the county. Positive cases in El Paso County include 540 females and 489 males; see accompanying graphics and map. There are 65 patients who are hospitalized, and 38 of those hospitalized are currently in ICU.

Dr. Hector Ocaranza, City/County Health Authority, reminds the public to continue following the City and County's Local Directives, which include wearing face coverings and avoiding social gatherings, especially as we approach Mother's Day weekend.

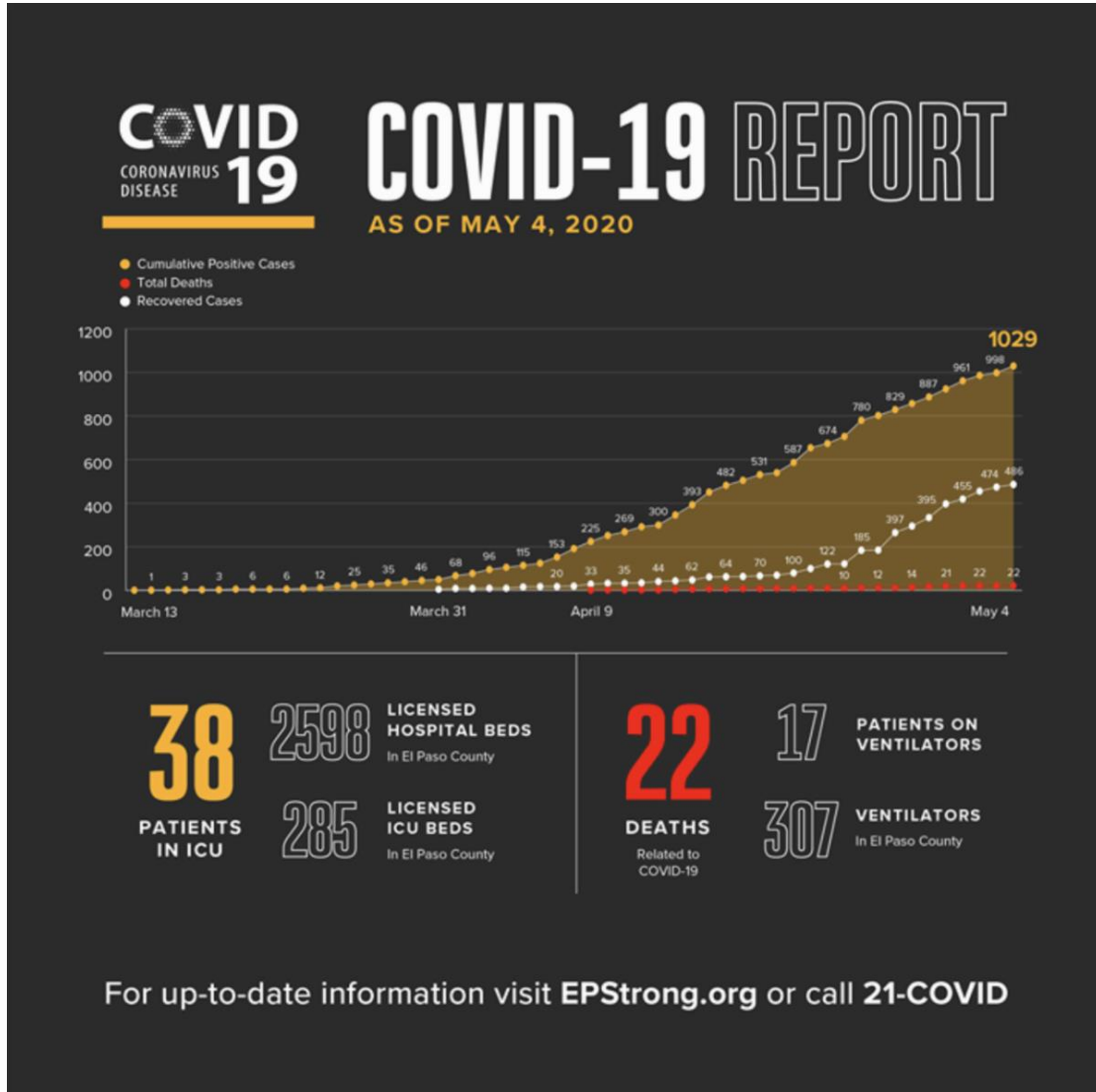

“Residents need to understand that social gathering are not allowed,” Ocaranza said. “Going shopping or out to eat with anyone that does not live with you such as your extended family or friends is not allowed. If you must go to the store, then please go alone and keep it to a minimum and try to avoid being out of your home. Take responsibility for yourself in order to keep our community safe.”

The public is reminded again that face coverings are locally mandated, but they are not required on anyone who has trouble breathing, is unconscious, incapacitated, or exercising outdoors and not within 6 feet of any other individual not from the same household. Wearing a face covering is not a substitute for maintaining 6-foot social distancing and hand washing, as these remain important steps to slowing the spread of the virus.

It is recommended that face coverings be cleaned daily. Individuals should be careful not to touch their eyes, nose and mouth when removing their face covering and wash their hands before and after removing the covering.

**Residents are encouraged to report non-compliance by calling the police department non-emergency at (915) 832-4400. Anyone with questions about the local directive can call 3-1-1.**

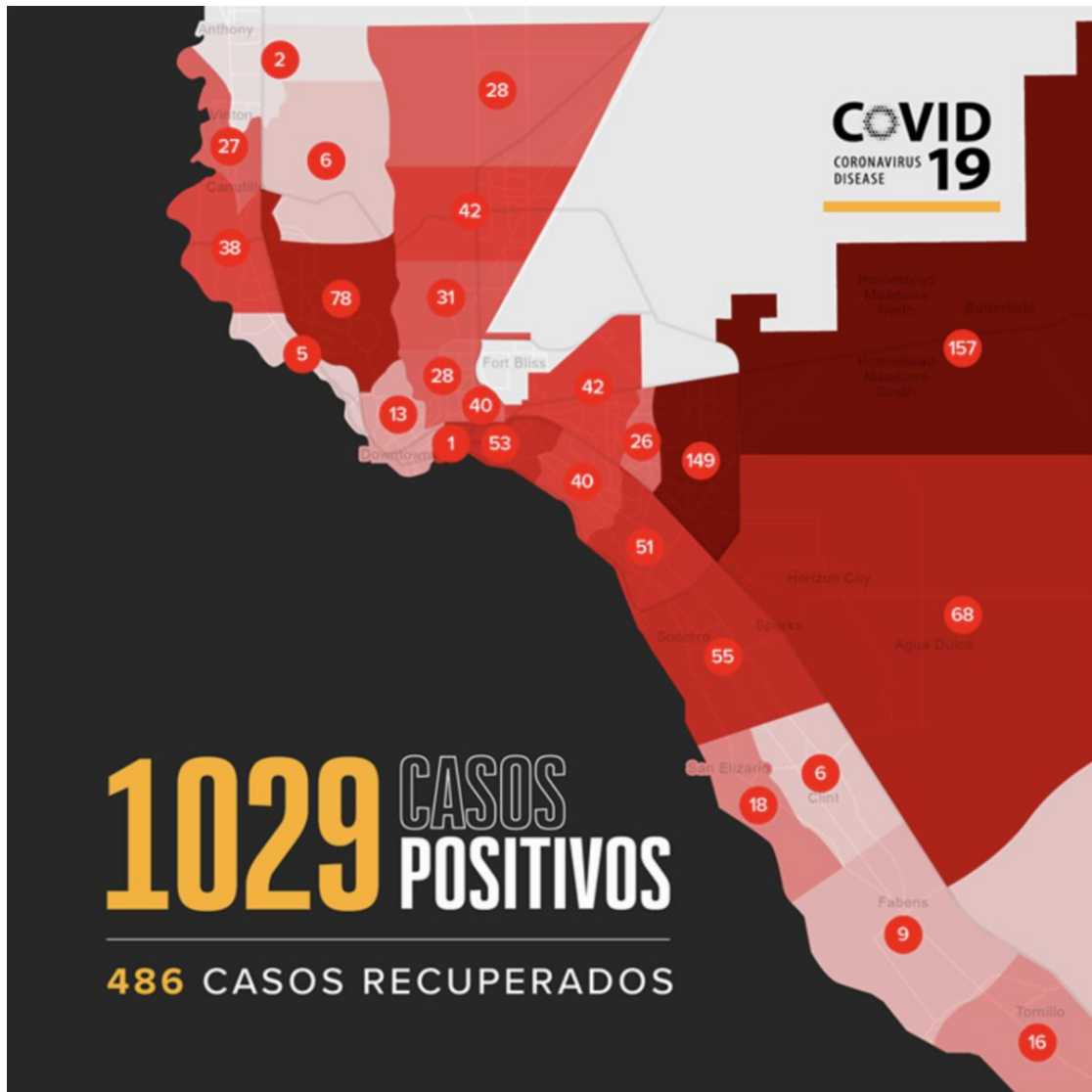

## **Numero de Casos Ascende a Más de Mil**

El Departamento de Salud Pública de la Ciudad de El Paso está informando 31 nuevos casos de COVID-19 que elevan el número acumulado del condado a 1,029, el número de muertes sigue siendo de 22.

Hasta la fecha, 486 personas se han recuperado de COVID-19; en consecuencia, hay 521 casos activos dentro del condado. Los casos positivos en el Condado de El Paso incluyen 540 mujeres y 489 hombres; ver gráficos y mapa adjuntos. Hay 65 pacientes hospitalizados y 38 de los hospitalizados se encuentran actualmente en la UCI.

El Dr. Héctor Ocaranza, Autoridad de Salud de la Ciudad / Condado, le recuerda al público que continúe siguiendo las Directivas locales de la ciudad y el condado, que incluyen el uso de cubiertas para la cara y evitar reuniones sociales, especialmente a medida que nos acercamos al fin de semana del Día de la Madre.

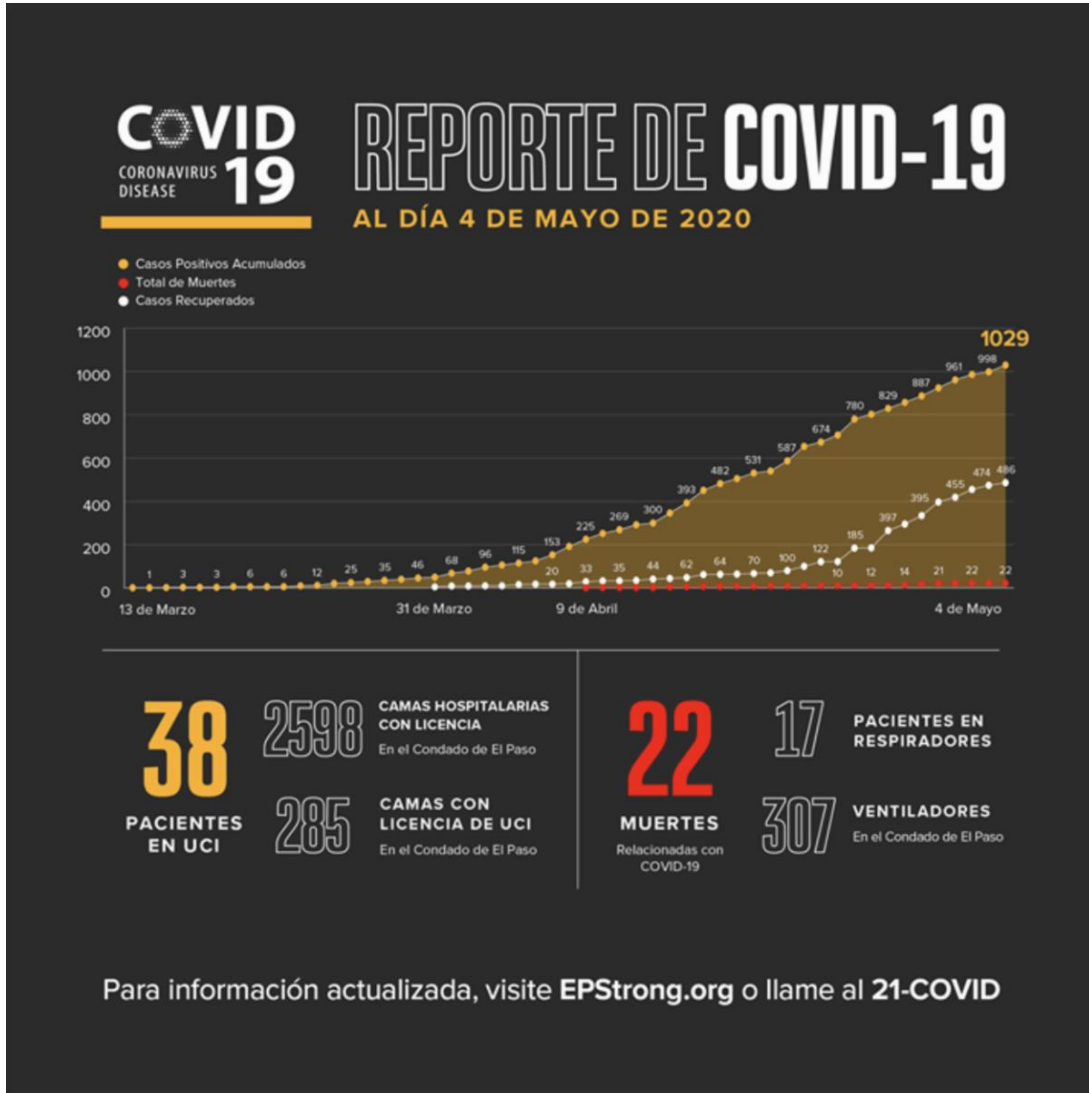


Gráfico muestra el aumento de casos y muertes por día a día. A partir de hoy, tenemos 1029 casos positivos y 22 muertes.

"Los residentes deben entender que la reunión social no está permitida", dijo Ocaranza. "No está permitido ir de compras o salir a comer con alguien que no vive con usted, como su familia o amigos. Si debe ir a la tienda, vaya solo y manténgalo al mínimo e intente evitar estar fuera de su hogar. Asumir la responsabilidad de usted mismo para mantener segura a nuestra comunidad."

Se recuerda nuevamente al público que los revestimientos para la cara son obligatorios a nivel local, pero no se requieren para cualquier persona que tenga problemas para respirar, esté inconsciente, incapacitado o haga ejercicio al aire libre y no a menos de 6 pies de cualquier otra persona que no pertenezca al mismo hogar. El uso de una cubierta facial no es un sustituto del mantenimiento del distanciamiento social de 6 pies y del lavado de manos, ya que estos siguen siendo pasos importantes para frenar la propagación del virus.

Se recomienda que los revestimientos faciales se limpien a diario. Las personas deben tener cuidado de no tocarse los ojos, la nariz y la boca al quitarse la cubierta de la cara y lavarse las manos antes y después de quitarse la cubierta.

## How It Spreads

The virus is thought to spread mainly from person-to-person, and possibly by touching your mouth, nose, or eyes after touching an infected surface.

Person-to-Person spread is defined as:



- Between people who are in close contact with one another (within about 6 feet).
- Through respiratory droplets produced when an infected person coughs or sneezes.

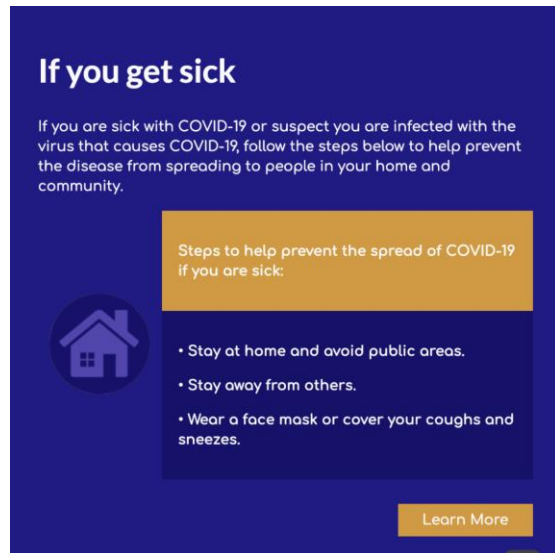
These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs.

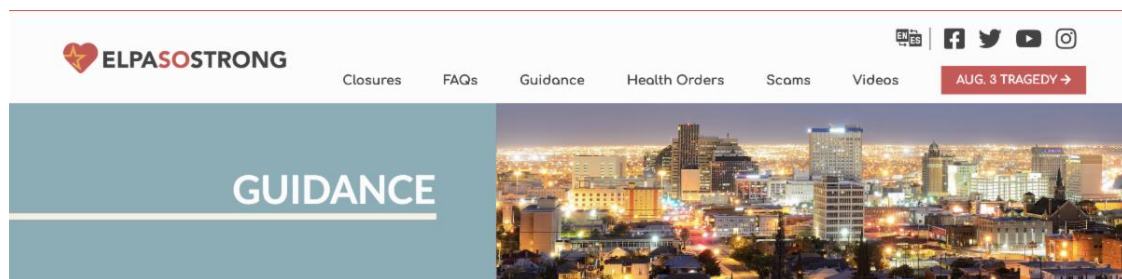


**Image:** How COVID-19 Spreads banner found at epstrong.org



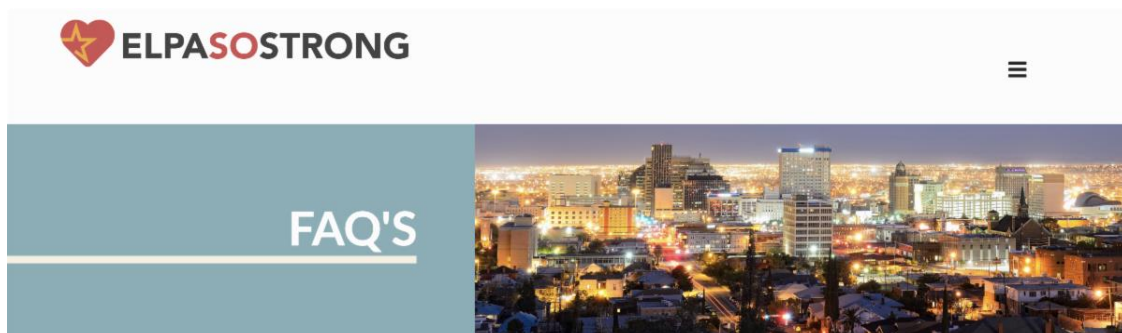

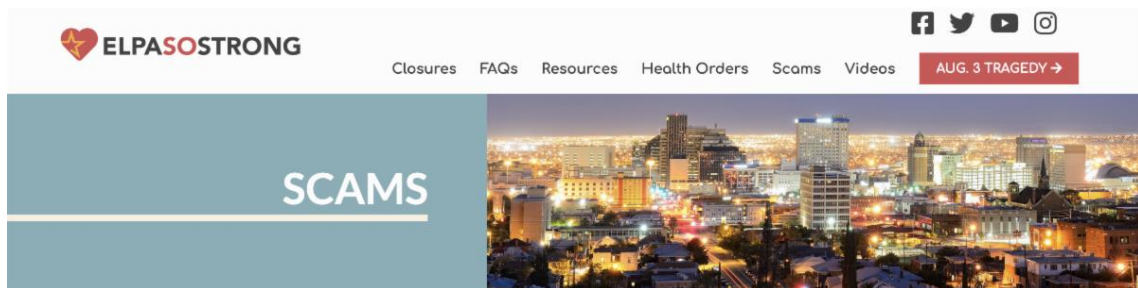

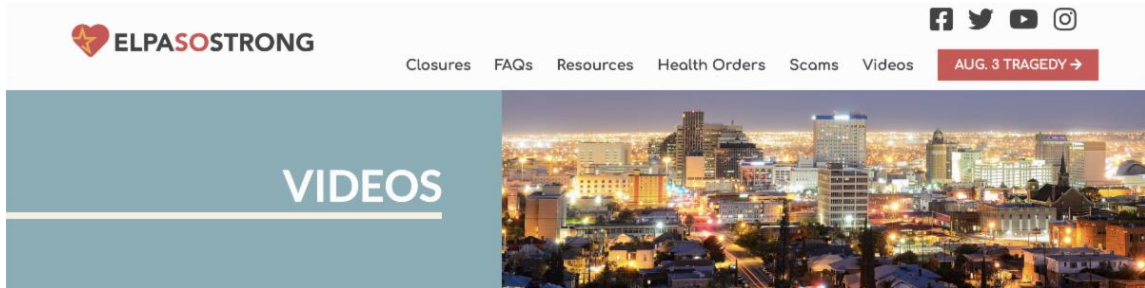
